



Sharp Performance Waiver and Liability Release

I hereby agree to participate and/or engage in the use of the fields, weight room, equipment, facilities and/or programs offered by The Hangar Indoor Sports Complex (hereinafter referred to as HIC), Sharp Performance (SP), and Kansas Youth Sports Foundation (KYSF) upon the understanding and agreement that:

- I am aware of the risks of illness or injury inherent in any sport and exercise, program or attendance of such event. These injury risks include, but are not limited to: being hit by balls, bats, flags, lightning, stepping or tripping in holes or other imperfections of the facilities surface; injury from insects, animals, birds or snakes; pulled muscles or other sprains, strains, dislocations, separations, broken or fractured bones, cerebral or spinal injuries. I am participating in HIC, SP and/or KYSF programs upon the express understanding that I hereby indemnify, waive and release HIC, SP and/or KYSF, its employees, agents, officers, Directors, Successors and Assigns from any and all claims, costs, liabilities, expenses or judgments, including attorney's fees and court costs (hereafter referred to as the "claims") arising out of my participation or attendance in the programs(s) or any illness or injury resulting there from, and hereby agree to indemnify and hold harmless HIC, SP, and KYSF from and against any and all such claims.
- The coaches and employees of the HIC, SP, and KYSF are not held responsible or liable for injuries or illness incurred while participating in any activity or event on the HIC premises or sponsored by HIC, SP, or KYSF.
- Acknowledging the desirability of a physical examination before participation, I represent to HIC, SP, and/or KYSF that I am physically capable of participation in the program of my choice without injury. I warrant and represent to you that I have no disability, impairment or ailment preventing me from engaging or participating in activity that will be detrimental or injurious to my health, safety, or physical condition if I do so engage or participate. I agree to a photo release, meaning my picture may be taken and used for marketing purpose of HIC, SP, and/or KYSF.
- Sharp Performance LLC, The Hanger Indoor Complex LLC, Kansas Youth Sports Foundation, and the Salina Airport Authority are not held liable for injuries, accidents or illness incurred while participating in any activity at the HIC or its outdoor premises.
- I assume full responsibility for myself, as well as anyone who participates at the HIC, SP, or KYSF facilities under this waiver, including any children/dependents, or any guests, and shall indemnify Management, its affiliates, agents and employees against any and all liability incurred by them toward such. I understand and agree that any person or party to my waiver will also be a party to this waiver/release. I hereby execute and deliver this waiver and release so that my listed participants or myself may participate in the programs offered by HIC, SP, and/or KYSF.
- I acknowledge that children/dependents, my guest and myself are aware that the HIC fields/ artificial turf second-generation recycled turf fields. This means imperfections in the surface may exist, such as but not limited to, rough seams, holes, lack of infill, tears.
- I acknowledge that the Hangar Indoor Complex LLC, Sharp Performance LLC and Kansas Youth Sports Foundation has the discretion to authorize use of medical personnel, and also the use of EMS to transport to local hospital to administer treatment to any injury or illness incurred while participating in programs at the HIC or programs sponsored by SP and KYSF.
